




Fig. 1 - Typical Forward Voltage Drop Characteristics (Per Leg)




Fig. 2 - Typical Values of Reverse Current vs. Reverse Voltage




Fig. 3 - Maximum Thermal Impedance Z_{thJC} Characteristics (Per Leg)




Fig. 4 - Maximum Allowable Case Temperature vs. Average Forward Current (Per Leg)




Fig. 5 - Forward Power Losses Characteristics (Per Leg)




Fig. 6 - Typical Reverse Recovery Time vs. dl_F/dt




Fig. 7 - Typical Stored Charge vs. dl_F/dt




Fig. 8 - Typical Peak Recovery Current vs. dl_F/dt




Fig. 9 - Typical Junction Capacitance vs. Reverse Voltage





Fig. 10 - Reverse Recovery Parameter Test Circuit



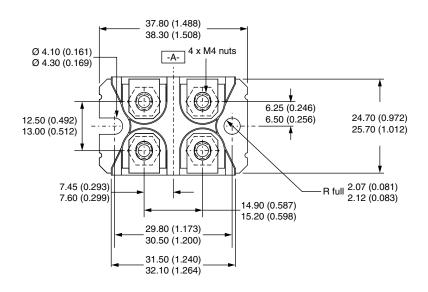

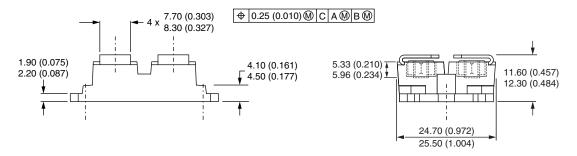
